OBJECTIVES

- Assess attitudes of school nutrition (SN) directors and directors of dietetic education programs regarding school nutrition operations as supervised practice sites for dietetics students.
- Examine dietetic students knowledge of and interest in school nutrition as a career.
- Identify existing materials from the National Food Service Management Institute (NFSMI) and the School Nutrition Association (SNA) which could be used to orient dietetic students to SN programs.
- Develop a guide for directors showcasing experiences meeting both Accreditation Council for Education in Nutrition and Dietetics (ACEND) competencies and the NFSMI competencies, knowledge, and skills for successful practice in school nutrition.

METHOD

- An expert panel of seven SN program directors and dietetics educators convened to discuss use of SN programs as supervised practice sites and to brainstorm learning experiences for students.
- Two focus groups of eight students each were conducted at the Academy of Nutrition and Dietetics' Food & Nutrition Conference & Expo to determine student knowledge of and interest in SN as a career. Detailed guidelines for 37 SN learning experiences for students were developed utilizing materials shared by dietetic education program
- directors, SNA, and NFSMI resources.
- Learning experiences were reviewed by the expert panel.


