# Why do we need professional standards for people working in school nutrition?





## **Final Rule**

- Published March 2, 2015
   Citation: 80 FR 11077
- Available at www. regulations.gov
- Implementation began July 1, 2015
  - School Year 2015/2016
- Establishes minimum requirements:
  - Hiring standards for NEW State/local directors
  - Annual training standards for ALL employees





## **Food Safety Certification**

BRANCE FROM BALL

- For New SFA Directors in All LEAs:
  - At least 8 hours of food safety training within 5 years prior to the starting date, or completed within 30 days of the starting date
- State agency has discretion to require current SFA directors to obtain food safety certification or training every 5 years

## **Required Annual Training Hours**

#### Table 1: Summary of Required Minimum Training for School Nutrition Employees

Job Category	Annual Requirements*
Directors	12 hours
Managers	10 hours
Staff	6 hours
Part-Time Staff (working less than 20 hours per week)	4 hours
Mid-year hires in all categories (January 1, or later)	One-half of training requirement for each job category

\*Annual requirements apply to the 12 months between July 1 and June 30.

## **Record-Keeping Requirements**

- SFAs are required to keep records of training
- If SAs allow 2-year period for SFAs to complete training:
  - Some training hours must be completed each year.
- Documentation of PS training is part of the Administrative Review
  - SFAs should also have records of individual staff members' training.
  - Retain records for 3 years, plus the current SY.





#### Professional Standards




Professional Standards for school nutrition professionals is a key provision of the Healthy, Hunger-Free Kids Act of 2010 (HHFKA). The rule, published March 2, 2015, requires a minimum amount of annual training hours for all state directors of school nutrition programs, state director of distributing agencies, school nutrition program directors, managers, and staff. Required training topic areas will vary according to position and job requirements. There are also minimum hiring standards for new state directors of school nutrition programs, state directors of school nutrition programs, state directors of new state directors of new state directors of new state directors of nutrition programs, state directors of distributing agencies that oversee USDA Foods, and school nutrition program directors.

In developing the final professional standards rule, USDA considered input from a variety of sources, including representatives from state agencies, school districts, and school nutrition professional associations. FNS carefully reviewed all comments and listened to the concerns of stakeholders.

The final rule eases hiring options for small school districts; adds hiring options that emphasize program experience; reduces the required annual training hours for all SFA personnel; phases in the training requirements in school year 2015-2016; and adds other practical flexibilities for the first year of implementation. The rule is effective beginning July 1, 2015.



#### Appendix C. Staff Guide to Professional Standards for Training

School nutrition employees now have annual training requirements. These Federal Standards went into effect July 1, 2015. The total hours of required annual training depends on your work schedule. The goal of training is to help you maintain or acquire the knowledge and skills needed to successfully operate school meal programs.

The first year (July 1, 2015-	Position	Defined As	Annual Hours*
June 30, 2016) ning requirements for all staff are 4 hours.	Staff	Works 20 or more hours weekly in direct program support	6
	Part-Time Staff	Works less than 20 hours per week in direct program support	4

"If hired on or after January 1, only half of the required hours for that school year are required.

#### What Counts as Training?

Training should apply to your work duties. In many cases, your manager or director will provide training. Options for job-specific training include:

- Online courses
- On-the-job training
- In-service training
- Local school nutrition organization training events
- State agency-sponsored classes
- Meetings sponsored by foodservice partners (vendors and commodity groups), including exhibits (as allowed by your State agency)
- College courses with job-specific content

A full 60 minutes of training counts as 1 training hour. Shorter time periods can count, too. For example, four 15-minute in-service training sessions equal 1 training hour. Not all training activities will count; they must be job-specific. Check with your manager or director.

Your district needs to keep training records for all school nutrition employees. Your manager or director will tell you how to track and report your training. Be sure to keep your own training record in case you change schools or districts.

Check with your manager or director to find out if your State agency allows a 2-year period to complete the training hours. If so, be sure to complete some training each year (July 1-June 30) and meet the total combined hours needed for 2 years.
